2021 – 2022 Food Service News!!!

The Ashland Independent School District Food Service Department is excited to kick off the 2021 – 2022 school year! We have adjusted all school menus to include tastier versions of entrees while staying within the United States Department of Agriculture’s nutritional guidelines. As a result of COVID-19, the Food Service Department will continue to follow guidelines set forth by the Kentucky Department of Education, the Kentucky Public Health Organization, and our local Health Department as well as enhanced sanitation in ALL areas and equipment. In addition, all Ashland schools will be participating in the Seamless Summer Option (SSO) and the Community Eligibility Provision (CEP). As a result of these programs, ALL Ashland schools will offer healthy meals every school day at NO Cost to the students during the 2021 – 2022 school year. ALL students will receive ONE FREE breakfast and ONE FREE lunch at no charge each day. Students will resume the process of going through the line and utilizing a meal card. The meal card has a bar code that will be scanned at the point of service allowing us to provide no contact service. Each school will distribute the meal cards. Parents may still deposit money on their child’s meal account which will allow students to purchase an additional meal, entrée, side, milk, and/or a la-carte item(s) at the prices listed below. **Please note Ashland Independent School District Board policy (07.1) does not allow student or adult charges.**
